

## Multi-Systemic Therapy Program

*A voluntary family-focused treatment program that supports a family's vision for a better future.*



# About Us

Multisystemic Therapy (MST) is an evidence-based co-occurring treatment program that provides intensive home, school, and community-based services to youth and their families experiencing challenges in the following areas: family conflict, school, juvenile justice, mental health, anti-social behavior, and/or child welfare.

Services are offered at no cost to the family. Our intensive therapy lasts approximately 3 to 5 months. Our individualized treatment model works to support the strengths and goals of the family.

MST addresses all environmental systems that impact the child and family. Our therapists work with families to create sustainable change in the home and in the community.

## MST can serve youth who:

- Are 12 to 17 years old
- Are receiving Medicaid\*
- Live in Mason or Thurston County
- Are experiencing challenges in two or more of the following areas:
  - School, Juvenile Court, Child Welfare, Mental Health, Family / Home
- Have escalated behavioral challenges that could include:
  - Running Away, defiance / refusal to follow rules of their community, school, or home, physical aggression, property damage, and/or substance use

\*Limited availability for Thurston County youth without Medicaid

## MST cannot serve youth who:

- Do not have a primary caregiver who is committed to having the youth in their home for at least 6 months
- Have primary challenges being suicidal and/or homicidal behavior or sexually acting out behaviors and do not demonstrate other delinquent behavior
- Have challenges related to severe psychiatric needs (i.e., psychotic symptoms are main driver to behavior)
- Have been diagnosed on Level 2 or 3 of Autism Spectrum Disorder or when cognitive/developmental delays are a main driver to behavior

# Outcomes

## At the time of discharge:

**91% of youth were living at home with their families**

**87% of youth were in school and/or working**

**85% of youth had no new arrests during treatment**

**82% of youth reduced their substance use\***

**86% of families had skills necessary to handle future issues**

**86% of families had improved relationships**

**89% of families had an improved network of supports**

**75% of youth improved in an educational/vocational setting**

**80% of youth were involved with pro-social peers and activities**

**79% of families sustained changes made during treatment**
